Temporary resident super

Last month, the Government announced proposed changes to temporary residents' super following industry consultation.

The former Government had proposed that super balances of temporary residents would be diverted to the ATO, and the balances would not attract interest. Under the new proposed changes, temporary residents' superannuation will remain growing in the superannuation fund for the entire time the person is residing in Australia.

Final approval of the changes is expected by the end of 2008.
